# **EXERCISE OVERVIEW**


Exercise Name	Hurricane Claire (Multiple Corridors)
<b>Exercise Dates</b>	5/10/2021 - 5/14/2021
Scope	The 2021 RHPC CMOC Hurricane Exercise series, named Hurricane Claire was a multiple-agency, multiple-site incidents designed to exercise and assess the capability of the coalition region to respond in a coordinated effort to a region wide Hurricane with cascading effects.
Purpose	The purpose of this exercise was to provide participants with an opportunity to evaluate current first receiving concepts, plans, and capabilities related to a severe weather outbreak. The exercise focused on coordination and continuity of operations.

# **SCENARIO OVERVIEW**

#### Scenario

#### **Region-wide Hurricane.**

The National Hurricane Center is monitoring a Tropical Disturbance in the Gulf of Mexico. This disturbance has been given a 40-60% chance to develop into a Tropical Storm. If further development occurs this could be our third named Atlantic Storm of the season, which would be Claire. SETRAC partnered with the National Weather Service from Houston/Galveston Texas develop a realistic scenario

#### **Ratings Definitions:**

**Performed without Challenges (P):** The targets and critical tasks associated with the core capability were completed in a manner that achieved the objective(s) and did not negatively impact the performance of other activities. Performance of this activity did not contribute to additional health and/or safety risks for the public or for emergency workers, and it was conducted in accordance with applicable plans, policies, procedures, regulations, and laws.

**Performed with Some Challenges (S):** The targets and critical tasks associated with the core capability were completed in a manner that achieved the objective(s) and did not negatively impact the performance of other activities. Performance of this activity did not contribute to additional health and/or safety risks for the public or for emergency workers, and it was conducted in accordance with applicable plans, policies, procedures, regulations, and laws. However, opportunities to enhance effectiveness and/or efficiency were identified.

**Performed with Major Challenges (M):** The targets and critical tasks associated with the core capability were completed in a manner that achieved the objective(s), but some or all of the following were observed: demonstrated performance had a negative impact on the performance of other activities; contributed to additional health and/or safety risks for the public or for emergency workers; and/or was not conducted in accordance with applicable plans, policies, procedures, regulations, and laws.

**Unable to be Performed (U):** The targets and critical tasks associated with the core capability were not performed in a manner that achieved the objective(s).

The following sections provide an overview of the performance related to each exercise objective and associated core capability, highlighting strengths and areas for improvement.

# **OBJECTIVE 1:**

# Assess the ability of the coalition to maintain communications when primary methods are affected.

The strengths and areas for improvement for each core capability aligned to this objective are described in this section.

#### HPP Capability 2: Health Care and Medical Response Coordination

#### Strengths

The *partial* capability level can be attributed to the following strengths:

**Strength 1:** Identified various tools available within the region to maintain communications Governmental Emergency Telecommunications Service (GETS), Amateur Radio (HAM), Satellite Phones, WAVE App, and other services identified through corporate systems.

**Strength 2:** Identification of alternate internet service capabilities to include but not limited to Satellite Internet.

#### **Areas for Improvement:**

The following areas require improvement to achieve the *full* capability level:

Area for Improvement 1: Amateur Radio Training

**Analysis:** Facilities that have access to Amateur Radios rely on volunteer organizations to operate their systems during times of emergency, and most do not have trained and/or licensed staff to do so.

Area for Improvement 2: Redundancy of Communications

**Analysis:** Most facilities/agencies identified having just one alternate method for communication when communicating in an Off the Grid environment. Building out plans to include secondary and tertiary methods ensuring communications during a widescale interruption of services.

# **OBJECTIVE 2:**

Evaluate the ability of the coalition members to Shelter-In-Place and/or evacuate as required prior to or during a hurricane.

The strengths and areas for improvement for each core capability aligned to this objective are described in this section.

#### **HPP Capability 3: Continuity of Health Care Service Delivery**

#### Strengths

The *partial* capability level can be attributed to the following strengths:

**Strength 1:** Regional Partnerships: Previous trainings and exercise have emphasized the importance and roles of strong community and regional partnerships. Most of the facilities and agencies have better coordinated their plans to include partners outside of the immediate area.

**Strength 2:** Par Levels of Emergency Supplies and Inventory: Facilities/agencies have identified the need to increase their level of emergency supplies through previous training, exercises, and real-world responses.

#### **Areas for Improvement:**

The following areas require improvement to achieve the *full* capability level:

**Area for Improvement 1:** Early Notification: Advance notification of evacuation orders for healthcare facilities and agencies.

**Analysis:** Socialization of current policies and procedures if any, for the advanced notification of evacuation for health care facilities and agencies from individual counties is needed.

**Area for Improvement 2:** Role of the CMOC: Understanding the role of the Catastrophic Medical Operations Center (CMOC) during emergency situations.

**Analysis:** Multiple facilities/agencies were not aware of the CMOC and its' role during an emergency situation for coordination, logistics, and dissemination of information as a last resort when all other local plans fail.
