The facility formed a Multidisciplinary Committee to develop the Neo MegaCode Algorithm to improve the processes and procedures both during and after the MegaCode occurrence. The process was recognized as a Best Practice by AAP state NICU reviewers in 2017 and 2020, as well as ACOG 2018 state reviewers for maternal designation. The report shows that Texas received a "D" in the overall grading, rating 40 <sup>th</sup> out of 52. Preterm birth rate has slightly declined from 11% to 10.8%. Harris County is at 11.9%, which is an "F" and has worsened from the previous year.
