The following sections provide an overview of the performance related to each exercise objective and associated HPP capability, highlighting strengths and areas for improvement.

### <u>Objective 1 – Assess the ability of the Regional Healthcare Preparedness</u> <u>Coalition (RHPC) to establish communications with the CMOC in the event</u> <u>of a region-wide disruption of communications.</u>

#### Overview

The December 2022 Off the Grid Drill was coordinated to run with the Houston Area Emergency Comm Teams monthly check-in. All facilities and agencies were provided with ICS forms 201 and 205. This information detailed the process for HAM radio operators, satellite phone, and text only options services the process to properly establish communications with the CMOC. In all there were 175 participating facilities/agencies able to establish alternate communication with the CMOC. Of the 175 participants there were 158 that communicated using web-based texting service, 12 utilizing the HAM Radio through the Houston Amateur Radio Network, and five (5) participating agencies using satellite to satellite phones.

#### **Additional HAM Information:**

The Houston Area Hospital Amateur Radio Net conducted the amateur radio component of the SETRAC Off the Grid Drill on 12/15/2022 from 1000 to 1100 hrs. The purpose of this net and the drill was to ensure that amateur radio stations located at hospitals and health care facilities were operational. Communications equipment like radios, cables, and antennas were tested through participation in the net. First responders, emergency operations centers and other served agencies were encouraged to check in. In addition, 12 visitors from the Ham in a Day Technician class also logged in under the supervision of the instructor, call sign N5NEV.

This was a directed net with the primary frequency 145.170 using the KA5QDG repeater with Net Control operating from the radio room at Houston TranStar, N5TRS.

#### #1 – Check-ins from hospitals

Four hospitals checked in from their radio rooms with a total of 7 EmComm team members. All were clearly audible with strong signals.
