# Call to Order

#### • Cyber Security Discussion

Gary Litton reminded the corridor members of the heightened security regarding cyber-attacks, especially in the healthcare sector, and he recommended the facilities discuss preparedness protocols and ensure they are in place. #### Ebola

Sarah Adams (ACCHD) gave an update advising they are monitoring recent travelers coming from Uganda, and they will be monitoring them for twenty-one days. Mr. Litton reminded the corridor members of the Ebola Transport Plan (RITA) which is posted on the SETRAC website. He asked that SETRAC be notified of any information as it develops for awareness and to assist as needed.

## EMTF Update (C306)

EMTF is working towards ensuring our RITA/IDRU ambulance transport teams are trained and equipped. The main focus after the new year will be towards MMU recruitment. Discussion on EMResource changes made to the system. In-Person EMResource trainings will be held regionally to improve the use of EMResource with Special Populations group. FSEDs meeting was held on November 10, 2022. Discussion on current RSV influx of pedi patients in hospitals. FSEDs seeing an influx but very minimal of patients needing to be transferred to higher level of care. FSEDs are D/C to home. If there is an increase in pedi patents needing higher level of care and not able to find bed placement will be advising SETRAC. Ebola planning and RITA plan was discussed. FSED were provided access to the RITA Plan and additional information pertaining to Ebola. Continue to discuss integrating the FSEDs meeting with all our corridor meetings in 2023. Will be providing EMTrack training to FSED in upcoming weeks. Corridor Meeting information will be provided once finalized.

Continue to meet with stakeholders and getting them familiar with SETRAC and reviewing plans. Providing email updates to stakeholders as requested by our preparedness partners.
