## Call to Order

Janay Yancey called the meeting to order at 2:15 pm.

## Minutes (C101)

Ms. Yancey requested review of the March minutes. Jason Minchew (CHI St. Luke's Livingston) made a motion to approve the minutes, Sondra Williams (Tyler County Hospital) seconded the motion, and the corridor members carried the motion. The minutes were approved as written.

## New Business

• Dialysis in Disaster

Gary Litton informed the corridor members David Ramirez with ESRD Network of Texas was scheduled to present on "Dialysis in Disaster" but was unable to attend. ESRD Network of Texas is an initiative that was spun up statewide approximately six years ago. Mr. Litton is working to reschedule him to speak to their network regarding what they do during a disaster and the protocols that fall in place for patient continuity and patient care.

Mr. Litton gave a basic overview of SETRAC's emergency management program within the healthcare infrastructure. The areas of focus for this presentation are SETRAC, CMOC, and the platforms used during a disaster (resources, past incidents, partner roles, etc.).

#### Training and Exercise (C104)

Mr. Litton advised the corridor members the After Action Report is in progress and will be posted to the SETRAC website as soon as completed. SETRAC will be participating in the TEDM Exercise scheduled for May 15<sup>th</sup>. The Training and Exercise schedule for May was distributed for information and reference *(filed with North Corridor minutes binder)*.

#### Special Populations (C104)

Mr. Litton highlighted some items in his update as outlined below (filed with North Corridor minutes binder).

In preparation for hurricane season, we hold an annual exercise for our Special Populations. Our annual Special Populations Exercise – Evacuation and Shelter in Place was completed on May 4<sup>th</sup>. An in-person tabletop was held on April 20<sup>th</sup> in Willis, TX. leading up to the virtual Full-Scale on May 4<sup>th</sup>. Over 70 attendees participated in the tabletop comprised from all over our 25-county region. A special thanks went out to facility staff that traveled over an hour to attend. The May 4<sup>th</sup> portion of the exercise had close to 300 facilities attending virtually. Facilities that submit the evaluation form for the exercise will receive a certificate of attendance and the AAR template for them to complete for their records to meet regulatory requirements.

Our first Emergency Preparedness Bootcamp will be May 9<sup>th</sup> in Texas city for our South Corridor area. On May 23<sup>rd</sup> a Bootcamp in Lufkin for our North Corridor will be held. We are finalizing a few items to hold a Bootcamp in Houston on June 14 for our Downtown Corridor. Once final, the registration information will be shared with our stakeholders.

FSEDs in TSA Q will be participating with our SETRAC Clinical committees (Stroke/Cardiac). Continue offering onsite EMTrack training to FSEDs. Continue to meet with new FSED Administrators and getting them familiar with SETRAC preparedness activities and reviewing their plans. FSEDs participated in the Rad Exercise in April.

**Ongoing Activities:** 

We continue to onboard new facilities on a weekly basis. Onsite visits are ongoing. For any facility that would like to meet to discuss preparedness planning please contact (Fidel).

Boot camp planning continuing with jurisdictions.

Providing email updates to stakeholders as requested by our preparedness partners.

Presenting SETRAC emergency preparedness overview to facility corporate personnel and local healthcare groups.

Trainings- EMResource in person trainings were held in March. Will continue to offer in person training throughout the region. UTMB providing a free training on how to develop a Respiratory Program for health care facilities. Next training on May 11<sup>th</sup> and June 13<sup>th</sup>. SETRAC Emergency Preparedness overview available to facility personnel.

## **Inventory** (C104)

Mr. Ericksen highlighted some of the items in his Inventory update as listed below (*filed with North Corridor minutes binder*).

- The TDEM Strategic PPE Stockpile Workgroup has picked back up. It will be a very slow process to determine the feasibility of the project, but Kyle Ericksen (SETRAC) will update as he has more information.
- SETRAC is actively working towards a new inventory tracking software that will streamline accountability for both the facilities and moving forward.
- SETRAC has recently supported the Iron Man Triathlon in the Woodlands, an Asset Showcase in Nacogdoches, and the Final Four NCAA Basketball Tournament
- If any agency or facility would like a tour of the SETRAC Warehouse to have a better understanding of the assets and resources we are able to provide, please contact Mr. Ericksen at <u>kyle.ericksen@setrac.org</u>.
- If a corridor feels that it would benefit from an Asset Showcase in their region, SETRAC would be happy to coordinate a day to provide the opportunity for partnering agencies to walk through our assets and learn more about our capabilities.

## • COVID Reporting

The Federal Declaration for COVID-19 crisis expires on May 11<sup>th</sup>; however, the COVID reporting has not ended. CNS wrote into their plans to collect this data until 2024 but they do not have the authority to enforce it. The hospitals' data will continue to be reported through EMResource daily and with the new guidelines, SETRAC will report the data to the state once a week.
