Exercise Name	Special Populations Evacuation and Shelter in Place (SETRAC Region)				
Exercise Dates	4/20//2023 & 5/4/2023				
Scope	This is an exercise planned to occur prior to Hurricane Season. Special Populations Stakeholders (Nursing Homes, Assisted Living Facilities, dialysis centers, home health/hospice, etc.) Healthcare agencies' inclement weather and hurricane plans will be tested, as well as procedures for evacuation, shelter in place and recovery systems. Exercise play is limited to registered participants.				
Purpose	The purpose of this exercise was to provide participants with an opportunity to evaluate current emergency plans, and capabilities related to a severe weather outbreak. The exercise focused on coordination and continuity of operations.



SCENARIO OVERVIEW

Scenario

Region-wide Hurricane.

The National Hurricane Center is monitoring a Hurricane in the Gulf of Mexico. A strong category 5 Hurricane to make landfall in Galveston Bay Texas. Wind speed at land fall up to 163 mph with gusts reaching 190 mph. After making landfall the center of circulation to track over Channelview, Sheldon (west of Crosby), Atascocita, Porter then turned NNE following highway 59, with the storm still at a cat-3 over Lufkin and Nacogdoches, before turning more NE toward Shreveport, LA. Extensive property and infrastructure damage possible along the track and east of the storm. SETRAC partnered with the National Weather Service from Houston/Galveston Texas develop a realistic scenario.



ANALYSIS OF CORE CAPABILITIES

Aligning exercise objectives and core capabilities provides a consistent taxonomy for evaluation that transcends individual exercises to support preparedness reporting and trend analysis. Table 1 includes the exercise objectives, aligned core capabilities, and performance ratings for each core capability as observed during the exercise and determined by the evaluation team.

Ratings Definitions:

Performed without Challenges (P): The targets and critical tasks associated with the core capability were completed in a manner that achieved the objective(s) and did not negatively impact the performance of other activities. Performance of this activity did not contribute to additional health and/or safety risks for the public or for emergency workers, and it was conducted in accordance with applicable plans, policies, procedures, regulations, and laws.

Performed with Some Challenges (S): The targets and critical tasks associated with the core capability were completed in a manner that achieved the objective(s) and did not negatively impact the performance of other activities. Performance of this activity did not contribute to additional health and/or safety risks for the public or for emergency workers, and it was conducted in accordance with applicable plans, policies, procedures, regulations, and laws. However, opportunities to enhance effectiveness and/or efficiency were identified.

Performed with Major Challenges (M): The targets and critical tasks associated with the core capability were completed in a manner that achieved the objective(s), but some or all of the following were observed: demonstrated performance had a negative impact on the performance of other activities; contributed to additional health and/or safety risks for the public or for emergency workers; and/or was not conducted in accordance with applicable plans, policies, procedures, regulations, and laws.

Unable to be Performed (U): The targets and critical tasks associated with the core capability were not performed in a manner that achieved the objective(s).

The following sections provide an overview of the performance related to each exercise objective and associated core capability, highlighting strengths and areas for improvement.

OBJECTIVE 1:

Evaluate the ability of staff to effectively initiate and coordinate response in evacuation and shelter in place plans for a hurricane threat and post landfall.

The strengths and areas for improvement for each core capability aligned to this objective are described in this section.

HPP Capability 2: Health Care and Medical Response Coordination

Strengths

The *partial* capability level can be attributed to the following strengths:

Strength 1: Facility/agency staff were aware of emergency procedures, priority status, methodology to determine supplies, equipment, and medications.

Strength 2: Emergency response plans were in place and up to date to address disaster events.

Areas for Improvement:

The following areas require improvement to achieve the *full* capability level:

Area for Improvement 1: Access to transportation, company transportation vehicle availability.

Analysis: Due to the number of activities taking place and personnel affected, transportation was delayed or not available due to the lack of resources. The pre-identified vehicles were either in use conducting different operations or not available when called upon through a MOA provider.

Area for Improvement 2: Coordination with local dialysis centers for availability and locations to send patients.

Analysis: Multiple agencies were unable to identify open Dialysis Centers for their patients. When contacting the centers it was identified that many were not in operation and back-up locations need to be identified early on and not at the last minute.

OBJECTIVE 2:

Determine the ability of staff to ensure continuity care of patients or an influx of patients and/or extended staffing shortages as a result of a hurricane.

The strengths and areas for improvement for each core capability aligned to this objective are described in this section.

HPP Capability 3: Continuity of Health Care Service Delivery

Strengths

The *partial* capability level can be attributed to the following strengths:

Strength 1: Identification of Shelter-In-Place or Evacuation procedures were discussed early on and involved the activation of their plans for possible activation.

Strength 2: Communications with residents, patients, and family members was conducted regularly.

Areas for Improvement:

The following areas require improvement to achieve the *full* capability level:

Area for Improvement 1: Early Notification: Advance notification of evacuation orders for healthcare facilities and agencies.

Analysis: Socialization of current policies and procedures if any, for the advanced notification of evacuation for health care facilities and agencies from individual counties is needed.

Area for Improvement 2: Additional redundant communications.

Analysis: Facilities and Agencies would not be able to communicate with staff, patients, emergency management agencies, and corporate should loss of communications occur. No back up communications equipment.
