A. Call to Order

E. EMTF Update

Carrie Cox highlighted the July training schedule which was distributed to the corridor members (*filed with East Corridor minutes binder*). SETRAC is partnering with Sam Houston State University for presymposium homeland security/emergency management training.

Ms. Cox reported Lisa Spivey has heard the requests for the participation letters and she is working on getting them out to the facilities. She also reported the After Action Report for the regional radiological exercise conducted in Spring 2023 is posted on the SETRAC website.

G. Special Populations Update (C101)

Fidel Calvillo highlighted the boot camps and EMResource training as outlined below (*filed with East Corridor minutes binder*).

The Emergency Preparedness Bootcamps have been held in Texas city for our South Corridor area; in Lufkin for our North Corridor; Houston for our Downtown Corridor; and in Port Arthur for our East Corridor. There have been 149 attendees for our bootcamps as of yet. One of the final two bootcamps for our hurricane season has been scheduled on August 1st in Lake Jackson (Civic Center). The registration information has been shared with our stakeholders.
