G7 has partnered with SETRAC who facilitate and run the exercise for the entire Gulf Coast Region they will be kicking it off next week. Dr. Davis reported the pediatric readiness preparedness course that has been held in Houston, Austin, and Dallas is going to take place in San Antonio this year probably late summer or early fall. She will make sure the flyer goes out through the listservs in case someone would like to travel there. At this point they have had over 400 unique attendees attend the course in the Gulf Region alone, that include Texas, Louisiana, Mississippi, Alabama, Georgia, Florida, and Puerto Rico in both Spanish and English. They will be doing revisions based on the survey metrics that went out the first two years of the course and additionally making it 508 compliant as well.
